

Olmsted Community Church
Annual Congregational Meeting Minutes
January 26, 2025

The meeting was called to order in the sanctuary and on Livestream by President Mary Golier at 11:20AM. A quorum, a minimum of 50 members, was met. Mary thanked those attending in person and virtually.

The meeting was opened with a prayer by Vice President Michelle Manno.

The congregation was led in the song "A House United," led by Katie Naar and Pastor Stephen.

Opening Remarks: In her opening remarks, President Golier thanked all who contributed to the Annual Report which can be found on line. We are continually asking how each of us can contribute our gifts to the church's mission in these exciting times of growth. Mary noted that there is a need for increased giving.

Old Business: President Golier called for a motion to approve the minutes from the April 7, 2024 congregational meeting. Bruce Gardner so moved. Sandy Hess seconded the motion. The motion carried.

New Business:

- Changes to the Constitution and Bylaws-

A sentence has been added to the 3/7/2024 draft of the Constitution. At line 165 the following has been added to Article 5 under The Guiding Board:

They (The Senior Minister, President, Vice President, Treasurer and Secretary) will recommend to the Guiding Board annually the chairs of committees and teams.

A paragraph has been added to the 4/7/2024 draft of the Bylaws. At line 148 the following has been added under Section 3. Committees and Teams:

Each Committee and Team will have a chairperson. The Chair shall ensure monthly meetings with an agenda, that minutes are recorded and reported to the Guiding Board, that there is a designated member for each Guiding Board meeting, and participate in the annual Ministry Plan.

A sentence has been added at line 169 in Section 3 – Christian Education Committee: *A Youth representative, active in the Youth Group, is encouraged to be selected by their peers to participate in both Christian Education Committee and Guiding Board meetings.*

Mary called for a motion to accept the changes to the Constitution and Bylaws. Jane Duffy so moved and Ken Yasch seconded the motion.

Kathy Henry suggested that the wording in Article 5 lines 162 - 165 of the Constitution referring to both the Guiding Board as a whole and the smaller Guiding Board consisting of the elected officers is confusing; a change in wording could clarify the intent. It was decided to leave the wording for now and perhaps offer a change at a later date. The motion carried.

- Election of Lay Leadership-
Because the Annual Meeting marks the official beginning of the new constitution governance, the following leaders are starting new terms.

Barbara Rook made a motion to accept the slate of nominations. Kate Goe seconded the motion which carried.

- Vote on the 2025 Ministry Plan-
The Ministry Plan was explained section by section by Treasurer Judy Collins. The 2025 Tithes and Offerings income budget is down from the actual 2024 Tithes and Offerings income. The 2025 Operating Income is set at \$374,000; Operating Expenses is set at \$406,000. The Outreach budget of \$25,000 was determined by tithing. Net activity deficit is \$18,000.

Mary called for a motion to accept the Ministry Plan. Jane Duffy so moved and Denise Oltmann seconded the motion. There being no discussion, a vote was held. The motion carried with one dissenting vote.

The meeting ended with the song “This is a Day of New Beginnings.”

Closing Prayer: Pastor Steven Gower

Call for motion to Adjourn: Vaughn Rockhold moved that the meeting be adjourned. Ken Bruce Gardner seconded the motion which carried.

The meeting was adjourned at 11:55AM.

“Language in the constitution and bylaws of OCC may be edited or revised (“housekeeping” changes) with approval from Guiding Board without bringing the item for a Congregational vote so long as the changes do not affect the intended meaning of the article(s)”

- The intent of this is to allow for more efficient work of leadership to make minor adjustments such as Gender neutral or inclusive language (ie - changing "him" to "him/her" or "person").
- Simple grammar or spelling corrections.
- Minor title changes so long as the role/function is not impacted.
